10	Brief description of Project	The proposed study will analyze the role played by family background and parents' health on childhood health outcomes. It will also look at the share of these factors in explaining child health over time. Parents' background allows us to explore intergenerational transmission of health inequities while socio-economic factors allow us to explore role played by circumstances beyond an individual's responsibility. This study will establish some stylized facts while can be useful in not only improving our understanding of health inequities in India but also improving effectiveness of public spending by allowing us to create more targeted policies.
